- 3.1.2 <u>Safe Operating Area (DC Operation) test</u>. Each transistor shall sustain the applicable test conditions and the following acceptance criteria shall apply:
  - (a) IC (for each transistor) shall not vary more than ±10% during the dc operation; and
  - (b) All other specified end-point test(s) limits shall not be exceeded, after the dc-operation test.






FIGURE 2. Maximum safe operating graph (continuous dc).

### 5. PACKAGING
